### **Board of Directors Recap**

The monthly Board of Directors (BOD) meeting was conducted online on April 17. Among other things, the BOD approved motions to keep the ranges closed and prohibit fishing at the lake until further notice. The decisions are based on Maryland Governor Larry Hogan's March 30 order closing recreational activities to limit the spread of the coronavirus and the interpretation of the Maryland Department of Natural Resources. #### Air Pistol "Goes Postal"

Susan Cassell is organizing a virtual or postal air pistol league. Members can set up a range at home with a cardboard box filled with newspaper, cardboard, or styrofoam packed in. They can use their .177 cal air pistol and shoot their targets (10-meter air pistol targets) and are shooting at 25 ft or whatever distance is available to participants inside their home. If participants don't have targets, Susan has a pdf file that they can print out to use. It is a 30-shot slow-fire match, 1 min per shot. Participants may shoot 5 or 10 shots per bull, but if shooting 10, they must be scoreable.

The shooting position is one-handed, standing. The 25 ft distance is measured from the firing line to the face of the target. Participants' feet may be up to, but not over the firing line. If they do not have the option to shoot at 25 ft. they should let Susan know and the distance can be reduced to accommodate everyone.

Participants will shoot each week until it is over. Members are welcome to join up at any time. When it is over, the plan is to celebrate at the lake with a picnic.

The targets should be emailed or texted to Susan. She will be scorekeeping and will send out weekly emails with results to those participating. Those with additional questions can contact Susan. Also, remember to HAVE FUN!
